Executive Summary

The Lakeshore Regional Police Service Crime Statistics Report is based on the Lakeshore Regional Police Service occurrence statistics for the fiscal years of 2020/2021 and 2021/2022. All references in this report to 2020/2021 and 2021/2022 are based on the fiscal year (April 1 to March 31).

The data for the Crime Statistics Report was derived from Lakeshore Regional Police Service Occurrence Stats (All Violations) for 2020/2021 and 2021/2022. This report is for the five First Nation communities of Kapawe'no First Nation, Sucker Creek First Nation, Driftpile Cree Nation, Swan River First Nation, and Sawridge First Nation.

Overall

Between 2020/2021 and 2021/2022, there was a <u>12% decrease</u> (1,708 occurrences in 2020/2021 in contrast to 1,497 occurrences in 2021/2022) in occurrences that the Lakeshore Regional Police Service responded to on the Five First Nations. This decrease may be a result of the COVID-19 restrictions that were in place for this reporting period.

It should be noted common police activities (e.g. wellbeing checks, assistance to the general public, persons reported missing, false alarms, suspicious person/vehicle/property) accounted for two hundred and twenty-one (221) of the 2021/2022 occurrences responded to.




Figure 1: Total Occurrences

Traffic Offences - Collisions

Between 2020/2021 and 2021/2022 there was a 4% decrease in traffic collisions the Lakeshore Regional Police Service responded to on the five First Nations. Collisions include off-road vehicles.




Figure 2: Total Traffic Collisions

Traffic Offences - Impaired

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall decrease of 39% in respect to occurrences related to impaired driving. The decrease in the number of occurrences may be directly related to enhanced enforcement activities by the Lakeshore Regional Police Service to ensure enhanced road safety for users of the five First Nations roadways. The number of impaired drivers apprehended, and the number of impaired drivers deterred from driving reinforces the Lakeshore Regional Police Service remains visible in each community and is focused on detecting and apprehending impaired drivers.

Traffic Offences (except collisions and impaired)

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>decrease of 35%</u> in respect to occurrences related to Traffic Offences except collisions and impaired.




Figure 4: Total Traffic - Except Collisions and Impaired

Provincial Statutes (except traffic)

Between 2020/2021 and 2021/2022 there was a <u>26% decrease</u> in respect to occurrences related to provincial statutes (e.g. Mental Health Act, Child Welfare Act, Liquor Act, 911 Act) on the five First Nations.




Figure 5: Total Provincial Statutes

Between 2020/2021 and 2021/2022 there was a <u>75% decrease</u> in respect to occurrences related to federal statutes (e.g. Indian Act, Firearms Act) on the five First Nations.




Figure 6: Total Federal Statutes

Other Criminal Code

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>increase of 2%</u> in respect to occurrences related to other criminal code (e.g. disturb the peace, harassing phone calls, uttering threats against a person, failure to comply with undertaking, appearance notice).




Figure 7: Total Other Criminal Code




Figure 8: Total National Survey Codes

Other FES Statutes and Economic Crime

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>decrease of 11%</u> in respect to occurrences related to other FES Statutes and Economic Crime (e.g. Corrections and Conditional Release Act, Family Orders & Agreements, Bank Act).




Figure 9: FES Statutes and Economic Crime

Drug Enforcement

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>75% decrease</u> in respect to illicit drug offences (e.g. possession, trafficking, production of illicit drugs). The decrease in drug occurrences may be a result of crime prevention activities and may also reflect the Lakeshore Regional Police Service's lack of resources to investigate these types of offences.




Figure 10: Total Drug Enforcement

Cannabis Act

Between 2020/2021 and 2021/2022 Sucker Creek First Nation and Driftpile Cree Nation both experienced 2 occurrences each year in respect to the Cannabis Act (e.g. Possession of Cannabis for Purpose of Selling, Possession of Illicit or over 30g Dried Cannabis, Possession of Cannabis for Purpose of Distributing).

Crimes Against the Person

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>9% decrease</u> in respect to crimes against person (e.g. assaults, harassment, threats).




Figure 11: Total Crimes Against the Person

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>4% decrease</u> in respect to crimes against property (e.g. theft under \$5000, theft over \$5000, break and enter, fraud).




Figure 12: Total Crimes Against Property

Common Police Activities

Between 2020/2021 and 2021/2022 the five First Nations experienced an overall <u>4% decrease</u> in respect to common police activities (e.g. wellbeing checks, assistance to the general public/other agency, persons reported missing, false alarms).

Common police activities are non-criminal occurrences; however, they are provided by the Lakeshore Regional Police Service as a service to the five First Nations.

Between 2020/2021 and 2021/2022 the most significant common police activities were assistance to general public/other agency, suspicious person/vehicle and well-being checks.




Figure 13: Total Common Police Activities

Clearance Rates

The Lakeshore Regional Police Service provides a range of services to the communities it serves (e.g. community services, crime prevention); however, the investigation of criminal offences leading to the identification and apprehension of offenders remains one of the primary functions of the Lakeshore Regional Police Service.

One of the mechanisms to measure effectiveness in performing this function is through the measurement of clearance rates (e.g. cleared by charge or cleared otherwise). The likelihood that a criminal incident is cleared, or solved, by police may be influenced by a number of factors including the type of offence being investigated, characteristics of the incident, police workload, the size and organizational structure of the police service, as well as the characteristics of the communities it serves.

It is important to note that clearance rates can also be impacted by a police service's philosophy on policing and other factors (e.g. police service and police officer discretion, the complainant declines to press charges, referral to a diversion program).

Lakeshore Regional Police Service clearance rates, in respect to the communities it serves on the five First Nations, are in alignment with other Alberta and Canadian police services.

Between 2021/2022 there were six (6) occurrences related to provincial traffic statutes and two (2) impaired driving.





Figure 14: Traffic Offences - Provincial and Impaired




Figure 17: National Survey Codes and FES Statutes




Figure 18: Crimes Against the Person





Figure 19: Crimes Against Property




Figure 21: Traffic Collisions




Figure 23: Traffic Offences - Other





Figure 24: Traffic Offences - Impaired






Figure 29: Crimes Against the Person


Figure 30: Crimes Against Property




Figure 33: Traffic Offences


Figure 34: Traffic Offences - Provincial




Figure 37: Other Federal Statutes


Figure 38: Other Criminal Code


Figure 39: Other Offensive Weapons





Figure 41: Drug Enforcement and Cannabis Act


Figure 42: Crimes Against the Person


Figure 43: Crimes Against Property




Figure 45: Traffic Offences - Provincial and Other




Figure 46: Provincial Statutes






Figure 48: National Survey Code




Figure 49: Crimes Against the Person





Figure 50: Crimes Against Property




Figure 52: Traffic Offences




Figure 54: Crimes Against the Person




Figure 55: Crimes Against Property
